It is difficult to anticipate the quantum of actual proceeds from divestment

- The Indian government is likely to achieve its fiscal deficit target of 5.9% of gross domestic product (GDP) in the financial year 2023-24, junior finance Minister Bhagwat Karad said on Monday.
- India's fiscal deficit in the first seven months of the financial year ending on March 31, 2024 was 8.04 trillion Indian rupees (\$96.86 billion), or 45% of the estimate for the whole year.

- ➤ He said India's future is bright as the country fared better than most others this year.
- ➤ The country's economy is thriving and gross domestic product (GDP) is on track to double to \$7 trillion over the next five years.
- ➤ Technologies such as generative AI (GenAI) is a potential antidote.
- ➤ "Looking ahead of 2024, we must be prepared for more disruption and volatility. The complexity of global governance will reach new heights as the world finds new rules to protect data privacy, curb inflation, reduce carbon emissions and perceptions of AI risk," Chandrasekaran said in his New Year message to employees.

Government has strictly no plans to put MEP on all agri-commodities: Commerce Ministry

- ➤ The government on Friday said there are "strictly" no plans to impose the minimum export price (MEP) on all agricultural products.
- Additional Secretary in the Department of Commerce Rajesh Agrawal said that there is no such intention of the government to look into exports of all agri products.
- > "Just want to clarify that the government has no intention to put in MEP on all agri products or review all agri products from the export perspective.

- He said that the committee getting a wider mandate does not mean that "the committee is there to look into each agri product and start recommending MEP for that".
- ➤ He informed that despite banning exports of non-basmati white rice, India has allocated 13 lakh tonnes of rice for exports to over 14 countries for their food security issues.
